 - 3 campus system with statewide reach
 - 6 major partner teaching hospitals
 - 6 well defined successful Colleges
 - Very strong educational programs
 - Full accreditation of all colleges
 - Maximum time accreditations
 - Growing class sizes in most colleges
 - Growing range of class offerings

- Largest post graduate programs in state
 - Advanced training
 - Certificates, residencies and fellowships
- Graduation rates in the high 90th percentile
 - Certification exam rates match graduation rates.
- Largest provider of health care professionals for the state

Goals

- Maintain and grow educational excellence
 - Core mission
- Increase research portfolio
 - Move from 100milion to 200 million
 - Move from respectable to top tier
- Increase and excel in clinical care
 - Add new programs of national stature
 - Increase clinical revenue

Challenges

- State allocation down 30% in 3 years
- No UT hospital obligated to provide us with funds

 - The state budget has not recovered
 - Will not be for some time
 - Some orange reductions are unavoidable
 - o As few as possible
 - Our hand is pushed by Freedom of Information Act
 - Negotiations in progress Colleges-Campus
 - We must raise our own funds to carry out our Mission and accomplish our goals.

 - Partner hospital joint ventures
 - Better contracting rates
 - Much better technical revenue
 - Direct academic support payments
 - UT LeBonheur first
- Advanced training
 - Negotiated improvement in hospital....
- State Legislature: Provider Bed Assessment
 - Programs providing payments with 30% from state plus 70% federal match
 - State declined to pay
 - TN hospital Assoc advanced Bill to pay state portion
 - Congress Approved
 - 23 million to UT (stable)
 - 140 Million to our UT teaching hospitals (Increase)
 - MED survival

 - UTHSC is a non formula unit
 - Even non formula units have a formula
 - Our % payment of formula is lower than other non formula units
 - Going back before THEC to address this
