- 1. Call to order by President Wilson: 4:01 PM
- 2. Announcements: New senators were welcomed to the Faculty Senste. There were 6 new senators present in the room with more online.
- 3. Approval of Minutes: The minutes from the June 9th Faculty Senate meeting were approved with changes to update the responses to the Upward Evaluation Survey to show final percentage values for response rates in each college.
- 4. Committee reports: Present Wilson asked each Committee Chair if they had updates to committee reports that had been submitted before the meeting. Senator Rao reported from the Faculty Research Committee Vice Chancellor Goodman discussed his plans to form planning committees for space and for a research development strategy. He also discussed his plan for possible changes in the research incentive program. Richard Magrid of UTRF discussed the new online inventions disclosure form. Debbie Smith presented plans for a new system to replace PAMS. In the new system, faculty profiles will be saved to save time in submitting grant proposals. Misconduct policy in being reviewed. An intramural committee for reviewing grants will be composed of 8 faculty members with 4 outside reviewers and possibly some ad hoc. All faculty reviewing grants will be given credit for 5% time. Four committee reports were submitted before the meeting and are attached to these minutes.

5. New Business.

- a. Faculty Senate Committee rosters and Goals for the academic year were presented by President Wilson. Most goals were continued from last year. It was noted that the Faculty Affairs Committee still needs a chair. Committees and goals are attached to these minutes.
 - President Wilson called for a vote on the committees. The vote to approve the committees and goals was: 38 for, including 3 online; none against; 2 abstaining.
- b. A resolution regarding APPR information posted on the Faculty Affairs website was presented. In early 2015 the Faculty Senate leadership was approached by individual faculty members who questioned whether the language published in Appendix J on the UTHSC Faculty Affairs website describing the Faculty Annual Performance and Planning Review (APPR) had received Faculty Senate and/or Board of Trustees (BOT) approval since it was different from the Appendix J version that had been posted up through 2013. The definition of "Needs Improvement' had been changed in the new document from "a level of performance that did not consistently meet all the agreed-upon goals and objectives" to "a level of performance that did not satisfy the goals, objectives, and/or work assignments". Since the answer to this question was not readily available, current and past Faculty Senate officers searched for documents including meeting minutes, previous versions of handbooks or Faculty Evaluation Manual drafts, and UT Board of Trustees documents to trace the history of this language. Those searches, as described in the resolution (included at the end of these minutes), demonstrated that in 2013 the UTHSC Administration had changed Appendix J from the BOT approved language. No such language was found in any documents that had been approved by the Faculty Senate or the Board of Trustees. Furthermore, the wording change had been specifically voted down by the Faculty Senate in 2011. Therefore, the resolution was developed to present the chronology of documents and events, and to request that the website language for Appendix J be returned to that which had received both BOT and Faculty Senate approval.

The vote in favor of the resolution was 41 in favor, 2 against, with one abstention. The resolution passed and will be delivered to the UTHSC and the UT System administrations. The full resolution is attached to these minutes.

6. It was announced that the TUFS meeting will be held in Memphis this weekend.

Resolution approved by the UTHSC Faculty Senate on September 8, 2015

Whereas: the Senate- and Board-approved 2010 UTHSC Faculty Handbook specifically refers to the Faculty Evaluation Manual (FEM) in multiple places (sections 4-6), meaning that the FEM is incorporated into the Handbook by reference, and therefore has the same authority as the 2010 Faculty Handbook itself; and

Whereas: since 1999, including the 2010 FEM, 1999 Faculty Handbook Appendix "J", the 2003 revision of the "Procedures for Annual Performance and Planning Review" (APPR), and in all online versions of the APPR through 2013), "needs improvement" is defined as "a level of performance that did not consistently meet all the agreed-upon goals and objectives"; and

Whereas: on April 7, 2011, the Faculty Senate Executive Committee unanimously rejected an alternate draft definition presented by the UTHSC Administration, which would have defined "needs improvement" as "a level of performance that did not satisfy the goals, objectives, and/or work assignments;" and

Whereas: in the 2013-2014 and 2014-2015 UTHSC website entitled "Annual Performance and Planning Review" (https://academic.uthsc.edu/faculty/annual review.php) posted APPR documents that were significantly altered from the authentic Appendix J (although its APPR was labeled "formerly Appendix J"); and

Whereas: the 2014 and 2015 altered documents for APPR defined "needs improvement" as "a level of performance that did not satisfy the goals, objectives, and/or work assignments," among other changes; and

Whereas: neither the Faculty Senate nor the Board of Trustees has approved such a definition or any of the other changes featured in the altered documents; and

Whereas: the 2014 and 2015 altered documents imperil the authority of the Faculty Handbook, the

principle of shared governance within the University of Tennessee and legitimacy of the annual review process for all UTHSC faculty members; therefore

BE IT RESOLVED: the UTHSC Faculty Senate urges the University of Tennessee System Administration to require the UTHSC Administration, including anyone in a position to evaluate faculty performance, to refrain from using altered documents for the conduct of faculty evaluations, and to direct the UTHSC administration to restore the original, Senate- and Board-approved APPR document to govern the annual faculty review process.
