Dr. G. Scott Morris Is December Speaker!

Dr. Scott Morris, M.D., M. Div. is founder and Executive Director of the Church Health Center (CHC). The mission of the CHC is to seek and to reclaim the Church's biblical commitment to care for our bodies and spirits. The CHC opened in 1987 to provide primary health care to low-income, uninsured working people of Memphis. The CHC, a health care ministry supported by a broad base of faith and medical communities, provides care to over 55,000 patients in its Clinic. The Clinic includes: primary care, dentistry, optometry, counseling, and social work services. The CHC has developed wellness and Faith Community Outreach ministries where the best disease prevention efforts of medicine are combined with the pastoral and spiritual care of the faith community.

Dr. Morris holds an undergraduate degree from the University of Virginia, a Master of Divinity degree from Yale University and the M. D. Degree from Emory University. A board certified family practice physician and an ordained United Methodist minister, Dr. Morris also writes a monthly column for the Memphis Commercial Appeal.
